- I will be a good sport and applaud all good plays whether they are made by my team or the opposition.
- I will treat all players in my sport as I like to be treated.
- I will cooperate with my coach, teammates and opponents.
- I will display modesty in victory and graciousness in defeat.
- I will participate for my own enjoyment and benefit, not just to please parents, supporters and coaches.
- I will respect the rights, dignity and worth of all participants regardless of their gender, ability, cultural background or religion.
- I will thank the opposition and officials at the end of the game.
- I will comply with applicable anti-doping policies.
- I will not bully or take unfair advantage of another competitor. argue with officials.
- I will not damage, neglect or fail to properly care for club property or facilities.
- I will not arrive at the venue or play sport while intoxicated.

BWCUCC Media Consent Policy:

I consent to being photographed or filmed by bwucc. I give my consent to bwucc to photograph or film the children legally under my care and nominated as members of the club in this registration form. I understand photographs and/or video may be used by the club, and club partners, for promotional purposes of any kind at any time in the future. BWCUCC Subscriptions Payment Policy:

- (A) Where any member is unable to play throughout the full season for any reason, including the late enrolment with the club during a season in progress, the Executive Committee may set a reduced amount of the subscription level for that member and, where necessary, refund any discounted amount for the full subscription amount previously paid.
- (B) The full subscription of every playing member or social member (not being a new member elected during the season) shall become due and payable on the 1st October of each new season.
- (C) Where the subscription of any playing member (not being a new member enrolling during the course of the season) remains unpaid after 30th November in that season that member may be suspended forthwith from participation in all club activities and from the use and enjoyment of club facilities until such time as the subscription is paid – unless arrangement for instalment payments have been agreed to by the executive committee.
- (D) Where the subscription of any playing member suspended pursuant to paragraph (c) of this rule remains unpaid after the 31st January following the suspension by the Executive Committee may forthwith or at any time in the future remove the name of that member from the roll of members and that member shall therefore cease to be entitled to any of the privileges of membership without however being released from his / her liability for the arrears of subscriptions due owing unless arrangements for instalment payments have been agreed to by the Executive Committee.
- (E) Every new member enrolling or registering during the season shall become due and payable immediately upon his / her enrolment or registration and the amount of such subscription shall be at the discretion of the Executive Committee.
- (F) Where the subscription of any new member enrolling or registering during the season remains unpaid after the 30th day of November during the season remains unpaid after the 30th day of November, or one month from the date of his/her enrolling or registering, whichever is later, that member may be suspended forthwith from participation in all club activities and the use and enjoyment of club facilities until such time as his / her subscription is paid unless arrangements for instalment payments have been agreed to by the Executive Committee.
- (G) Where the subscription of any new member enrolling or registering during the season remains unpaid after the 31st January in the season of his / her enrolling or registering or one month from the date of his / her enrolling or registering the Executive Committee may forthwith or at any time in the future remove the name of that member from the roll of members and that member shall therefore cease absolutely to be entitled to any of the privileges of membership without however being released from his/her liability for the arrears of subscriptions due owing unless arrangements for instalment payments have been agreed to by the Executive Committee.
- (H) A Member's subscription will be in default if their subscription is unpaid, in full or in part, after the last playing Saturday of the season, and will remain in default until all amounts owing have been paid in full, such amount being the subscription level originally applicable, together with any reasonable debt collection charges which, at the Executive Committee's discretion, are incurred by the Club.
